
2. In this distressing moment, our collective efforts can make a significant difference. I urge all our officers and staff to contribute financially to the Disaster Management Cell of their respective Commissionerate. If the Cell has not yet been constituted in your Commissionerate, steps may be taken to urgently establish the same under section 36 of the Disaster Management Act, 2005 (CBIC Circular on formation of the DMC enclosed).

3. We can give the option of giving consent for deductions from our salary through the DDO. We may also appeal to our colleagues outside the Zone, retired officers, and key stakeholders to contribute generously to the Disaster Management Cell of your Commissionerate.

4. Once we are able to raise a substantial amount, we will collectively utilise the same at the Zonal level for providing meaningful and long-term relief and rehabilitation for the affected communities. This could include measures like building homes, schools and medical facilities for the affected. The specific activity for which the fund shall be utilised will be decided collectively by a committee comprising of all the Commissioners in the Zone.

Kind reference is invited to this office letter F.No. 917/20/RBA/Disaster Mgmt./HRD-ID/2018 dated 14.03.2019 on the foregoing subject wherein it was requested to set up a Disaster Management Cell for your Zone. Further, kind attention is also invited to this office letters of even number dated 02.05.2019 and 22.05.2019 vide which all the field formations were asked to submit an action taken report as per Section 36 of the DM Act, 2005 and NDMA guidelines.

2. However, it is noted that no communication has been received from your Zone regarding constitution of Disaster Management Cell and appointment of Nodal Officers for monitoring of Disaster Management activities in all the field formations under your Zone.
3. It is once again requested to set up Disaster Management Cells in all field formations under your Zone, and appoint a Nodal Officer, not below the rank of Joint Commissioner to deal with all aspects of Disaster Management relating to Zone. Name and designation of the Nodal Officer along with contact details may be forwarded to this office at the earliest. Further, an action taken report in respect of your Zone as per the responsibilities mentioned in Section 36 of the DM Act, 2005 and NDMA guidelines may also be forwarded.
