#### Establishment Circular 30/2024

Sub: Recommendations for Jeevan Raksha Padak Series of Awards-2024reg.

In pursuance of the letters from Ministry of Home Affairs dated 01.04.2024 & 29.07.2024 in F.No. 17/2/2024-Public and the subsequent Office Memorandum issued by the Ministry of Finance dated 22.08.2024 in F.No. O-22012/1/2023-Coord. recommendations are invited for the Jeevan Raksha Padak series of awards -2024.

**Jeevan Raksha Padak** series of awards are given for meritorious acts of humane nature in saving the life of a person in incidents like drowning, accidents, fire accidents, electrocution, landslides, animal attack and rescue operation in mine etc. As the name of the award suggests, the award is given to a rescuer for saving someone's life. It is given in the following three categories:-

- (i) **सर्वोत्तम जीवन रक्षा पदक**-बचावकर्ता के जीवन के लिए बहुत बड़े खतरे की परिस्थितियों में जीवन बचाने में विशिष्ट साहस के लिए सम्मानित किया गया।
- (i) **Sarvottam Jeevan Raksha Padak**-awarded for conspicuous courage in saving life under circumstances of very great danger to the life of the rescuer.
- (ii) उत्तम जीवन रक्षा पदक- बचावकर्ता के जीवन के लिए बड़े खतरे की परिस्थितियों में जीवन बचाने में साहस और तत्परता के लिए प्रदान किया जाता है।

- (ii) **Uttam Jeevan Raksha Padak** awarded for courage and promptitude in saving life under circumstances of great danger to the life of the rescuer.
- (iii) **जीवन रक्षा पदक**:- बचावकर्ता को गंभीर शारीरिक चोट की परिस्थितियों में जीवन बचाने में साहस और तत्परता के लिए सम्मानित किया जाता है।
- (iii) **Jeevan Raksha Padak**:- awarded for courage and promptitude in saving life under circumstances of grave bodily injury to the rescuer.

जीवन के सभी क्षेत्रों के व्यक्ति इन पुरस्कारों के लिए पात्र हैं। यह पुरस्कार मरणोपरांत भी प्रदान किया जाता है। यह ध्यान दिया जाना चाहिए कि इस पुरस्कार के लिए सिफारिशों पर पुरस्कार समिति द्वारा वीरतापूर्ण कार्य के प्रदर्शन की तारीख से दो साल की अविध के भीतर विचार किया जाता है।

Persons from all walks of life are eligible for these awards. The award is also conferred posthumously. It may be note that the recommendations for this award are considered by Awards Committee within a period of two years from the date of performance of the gallant act.

Therefore, for the year 2024, any recommendation in respect of which the date of performance of the life saving act falls prior to 1st October 2022 should not be forwarded for consideration.

जीवन रक्षा पदक श्रृंखला के पुरस्कारों के लिए सिफारिशें केवल गृह मंत्रालय द्वारा डिज़ाइन किए गए पासवर्ड संरक्षित राष्ट्रीय पुरस्कार पोर्टल (यूआरएल: https://www.awards.gov.in) के माध्यम से ऑनलाइन मोड में भेजी जा सकती हैं। सिफारिशों में उक्त पोर्टल में उपलब्ध प्रारूप में निर्दिष्ट सभी प्रासंगिक विवरण शामिल होने चाहिए, जिसमें वर्णनात्मक रूप में एक उद्धरण (अधिकतम 250 शब्द) शामिल हो, जिसमें स्पष्ट रूप से घटना के अनुक्रम-वार विवरण, बचावकर्ता द्वारा प्रदर्शित साहस और तत्परता शामिल हो। जीवन के लिए ख़तरा और व्यक्ति (बचावकर्ता) की विशिष्ट भूमिका/योगदान भी।

The recommendations for the Jeevan Raksha Padak Series of awards can be sent in **online mode only** through the password protected Rashtriya Puraskar Portal designed by the Ministry of Home Affairs (URL:https://www.awards.gov.in). The recommendations should contain all relevant details specified in the format available in the said portal, including a citation in narrative form (Max. 250 words), clearly bringing out the sequence-wise details of the incident, courage and promptitude displayed by the rescuer and danger to life and also specific role/contribution of the person (rescuer).

Jeevan Raksha Padak series of awards are given for meritorious acts of humane nature in saving the life of a person in incidents like drowning, accidents, fire incidents, electrocution, land slides, animal attack and rescue operation in mines etc. As the name of the award suggests, the award is given to a rescuer for saving someone's life. It is given in the following three categories:-

- Sarvottam Jeevan Raksha Padak awarded for conspicuous courage in saving life under circumstances of very great danger to the life of the rescuer.
- ii) Uttam Jeevan Raksha Padak awarded for courage and promptitude in saving life under circumstances of great danger to the life of the rescuer.
- iii) Jeevan Raksha Padak awarded for courage and promptitude in saving life under circumstances of grave bodily injury to the rescuer.
- 2. Persons in all walks of life are eligible for these awards. Members of the Armed Forces, Police Forces and of recognized Fire Service etc. are also eligible for these awards provided the life saving act is performed by them. As the Prime Minister's Police Medal for Life Saving" instituted by Ministry of Home Affairs has been subsumed in the "Jeevan Raksha Padak", the members of CAPFs/CPOs and Police Forces, who have shown exemplary devotion to duty in saving human life, are also eligible for Jeevan Raksha Padak. The award is also conferred posthumously.

- 3. Every year, the Ministry of Home Affairs invites recommendations from all State Governments/UT Administrations, Ministries/Departments of the Government of India, CAPF and other authorities for these awards. The recommendations are examined by a high-level Awards Committee, which makes its recommendations to the Prime Minister and the President. After approval of the President, the decoration of the award, i.e., Medal and Certificate along with the monetary allowance in respect of the awardees, are sent to the concerned recommending authorities.
- 4. Over the last few years, it has been observed that various acts of life saving by individuals during natural calamities, accidents, extremists attack, drowning/fire incidents etc. are reported in the print and electronic media. However, such valiant and gallant acts go unrecognized in the absence of suitable nominations by the State/UT Government and authorities under whose jurisdiction such acts take place. You would appreciate that awards and decorations are tangible tokens of recognition of the services rendered by an individual. Such awards encourage and motivate others for similar action in the hour of need. The concerned authorities are, therefore, requested to send suitable and deserving nominations to this Ministry for consideration. It may be noted that the recommendations for this award are considered by Awards Committee within a period of two years from the date of performance of the gallant act. Therefore, for the year 2024, any recommendation in respect of which the date of performance of the life saving act falls prior to 1st October 2022 should not be forwarded to this Ministry for consideration.
- 5.
