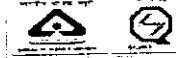

Subject: Posting of officers at the level of Inspectors in the office of GST Council— regarding.

Goods & Services Tax Council (GSTC) Secretariat is a Constitutional body which has been constituted on 15th September, 2016. It is entrusted with the work of organising meetings of the GST Council including the drawing up of the agenda notes and preparing minutes of the Council meetings, assisting different Committees / Group of Ministers (GoM) constituted by the GST Council, examining various representations relating to GST Laws / Rules / Rates, administration and logistics etc. It also has the mandate to carry out tax research, print and publication and documentation relating to GST.

2. In this regard, willingness / requests / communications have been received on individual basis from some Inspectors who are posted in different CGST Commissionerates to work in the office of the GSTC. At present, CGST Cadre Control Chief Commissionerate, Delhi have posted two Inspectors to the GSTC on loan basis.

3. The functions mandated to be performed by the GSTC requires more officers at the level of Inspectors. It is proposed to take 6 Inspectors on loan basis from Commissionerates situated outside Delhi.

4. In view of the above, it is requested to forward representations of good and willing officers at the level of Inspector on loan basis, at least for two years.
