2	Supply and painting of the Wall – Removing old paint with sand paper, One Coat Cement Primer and Two Coat Emulsion (Patch Work Where ever necessary) – Total Area 796 Sq.ft.
3	Ceiling Work with gaggged PVC Sheet - Total Area 340 Sq.ft.
4	Powder coating of old aluminium door and refitting half of the portion with glass – 34 Sq.ft.
