

1. The tenderer shall be authorised dealer or bonafied publishers as on date

2. In case of supplier, he must possess an experience of three years of supplying books. In case of authorised dealer, he must be a dealer of the said company/brand for at least one year. If the tenderer is not a manufacturer , authorization letter from the manufacturer should be submitted along with the tender

3. Tenderer should have completed at least three (03) similar type of supply or order satisfactorily with state/central government organisation or under taking (List of such orders should be enclosed).

The bidder should be free from all encumbrances and there shall not be any vigilance case/CBI case/Court Case pending against him and also should not be black listed by any Govt./Semi. Govt./Private institution .

4. The vender must have a valid PAN No. and a valid Bank Account in any of the Nationalised Banks/Scheduled Banks (In case of Ltd./Pt. Ltd/Partnership Firm, the PAN and Account shall be in the name of the Firm/Company and in case of Individual Ownership, the PAN and Account may be in the name of Owner).

5. The supplier/tenderer must have a service center in Kerala for providing immediate service support or must ensure immediate service in case they have no service centre in Kerala.

6. The tenders shall be submitted "The Chemical Examiner,Gr-I, O/o The Commissioner of Customs, Customs House Laboratory, W.Island, Kochi-9", along with all the tender documents and the Tender Acceptance Letter duly signed in all the pages.
