Sl. No.	Description of the Work
1	Providing and laying factory made interlock block tiles with adequate bedding consisting of a mixture of M sand and baby metal with adequate slopping a. at the open area between LP section class room and toilet complex b. the open area in front of the kitchen(total area approximately 910 sq.ft.)
2	a) Construction of a shed as an extension to the existing kitchen with GI pipe and Oranium roofing sheet with one coat epoxy paint. b) Raising the floor of the shed area with adequate building rubbles and finishing it with plain cement concrete (Approximately 9 M3)
3	Constructing a 11 Lx 30cm W x1 ft depth drainage with adequate slopping at the left side of the LP section class room.
4	To partially demolish the existing concrete wash basin in front of the LP class room and making it into a planting block.
5	Plumbing and or charging work in the two wash basin set and making an SS grill for protecting the water Purifier in the LP section area.

You are requested to inspect the site and submit your quote for the above work on or before 3.00pm on 27.12.2019 to the Commissioner of Customs, Cochin. The bids will be opened at 4.00 pm on 27.12.2019 at the chamber of Joint Commissioner. Interested bidders are welcome to take part.
