1	Construction of Compound wall at the backside of the Guest House a) Earth excavation of the ordinary soil for foundation (16.7x0.20x0.20M ³) b) RCC Work in 1:2:4 using 20mm metal for foundation beam (16.7x0.20x0.20M ³) c) Hollow bricks and cement construction along with plastering in cement mortar 1:5 for the walls
2	False ceiling roof replacement in Room No.1 with Calcium Silicate Board or Fibre Cement Board (RAMCO or SHERA) board 6mm. Total Area 169 Sqft.
3	Hand Rail fixing in the sit out area of the main Guest House building with GI Pipe with Epoxy Paint. Total Length:1.75 Running Meter.
4	Replacement of the Back Door of the Guest House with Wood door and Water proofing it with PVC Sheet.
5	Works in the Bed Room located near the Car Shed a) New Sintex Door between Bath Room and Bed Room. b) Plumbing Work EWC (CERA/JOHNSON) and One Tap in the Toilet. One Wash Basin, Head Shower and 2 Taps in the Bath Room. Pipe Universal/Supreme
6	Yard Tile paving to connect the cemented path to the Room near the Car Shed. Total Area : 156 Sqft with Kajaria Tile 30x30x7cm.
