1	Old Paint removing on the walls with sand paper: One coat cement primer, two coat putty and two coat emulsion paint. Total area – 842 Sq.ft. approximately
2	Ceiling Work by using gauged TKT 10mm PVC Sheet with sufficient LED light fittings – Total Area Approximately 326 Sq.ft.
3	Completely removing the old Paint on the doors ventilators and windows with sand paper and polishing both sides with clear coat (approximately 228 sq.ft.)
4	Supply and Laying of 60x60 cm superior quality vitrified Floor Tiles by using thin set Adhesive paste (approximate area 375 Sq. ft)
5	Interior work- making cubicles a) Making Front tables with 5 sections using 18 mm laminated MDF sheet (75 cm width) approx 56 Sq.ft. b) Making cubicles 4 partition with 4mm Plywood section covering with laminated MDF sheet approx. 124 sq.ft c) Making of side rack with 3 section by using 18mm laminated MDF sheet.approx 158 sq. ft.
