## TRADE FACILITY CIRCULAR No.01/2025

<u>Sub</u>: Appointment of Approved Valuers for valuing Gold and Silver Jewellery for Import /Export from Cochin International Airport, Air Cargo Complex, Nedumbassery PAD and Custom House, Cochin-reg.

Attention is drawn to the trade and public regarding appointment of approved valuers for valuing Gold and Silver Jewellery as well as jewellery studded with precious stones/synthetic stones for export and import from Cochin International Airport, Air Cargo Complex, Nedumbassery PAD and Custom House, Cochin.

2. The panel of jewellery experts has been constituted and the following persons are appointed as Valuers for valuing Gold Jewellery and Silver Jewellery as well as Jewellery studded with precious stones/synthetic stones for export from /import at Cochin International Airport, Air Cargo Complex, Nedumbassery, PAD and Custom House, Cochin as well as for valuation of seized/confiscated gold/silver in all forms, gold/silver Jewellery and Jewellery studded with precious stones/synthetic at Airport.

3. The fees to be charged by registered valuers for valuation of any asset shall not exceed the amount calculated at the following rates based on the market value namely:-

Sl	Limit of asset	Fees
No.		
1	On the first Rs. 5 lakhs of the asset as valued	1/2 per cent of the value
2	On the next Rs. 10 lakhs of the asset as valued	1/5 per cent of the value
3	On the next Rs. 40 lakhs of the asset as valued	1/10 per cent of the value
4	On the balance of the asset as valued	1/20 per cent of the value

- 4. Where the amount of fees calculated is less than Rs.500, the appointed valuer may charge Rs. 500/- as fees.
- 5. The charges of approved Valuers shall be paid by the Importer/Exporter concerned. In respect of seized goods/consignments taken up for disposal by the department, the charges shall be paid by the department.
- 6. Trade is hereby advised to engage the services of any of the above members to facilitate the valuation of Gold and Silver jewellery as well as jewellery studded with percious stones/synthetic stones for export from/import at Cochin International Airport, Air Cargo Complex, Nedumbassery, PAD and Custom House, Cochin in terms of the notification pertaining to the jurisdiction of Customs, Cochin.
- 7. This Circular shall be effective from the date of issue.
