**OFFICE ORDER No. 73/2024**

**Sub: Promotion to the grade of Superintendent of Customs (Preventive) -reg.**

The following officers were considered for promotion to the grade of Superintendent of Customs (Prev.) in the DPC held on the dates mentioned against their respective names as tabulated below. In view of the Disciplinary and prosecution proceedings pending against them, the DPC kept its findings in respect of the officers in "sealed cover".

2. Consequent to the disciplinary and prosecution proceedings coming to its logical conclusion, the Departmental Promotion Committee held on 09.07.2024 opened the sealed covers pertaining to the officers figuring at Sl. No. 1 to 6 in the table below, in terms of DoPT OM No. 22011/4/91-Estt(A) dated 14.09.1992 and found them fit for regular promotion from the date mentioned in their respective DPC/sealed cover. In respect of the officer figuring at Sl. No. 7, the DPC opened the sealed cover after the currency of penalty imposed on the officer expired, and accordingly assigned the promotion date after the completion of currency of the penalty period, as mentioned against his name in the table.

3. Accordingly, the following officers are notionally promoted to the grade of Superintendent of Customs (Preventive), Group 'B' on regular basis, in Level-8 (Rs. 47600/- - Rs. 151100/-) in the 7<sup>th</sup> CPC Pay Matrix (pre-revised Pay band Rs. 9300/- - 34800/- with Grade Pay of Rs. 4800/-) plus such allowances as may be applicable with effect from the date shown against their names. The seniority of the officers in the cadre of Superintendent of Customs (Preventive) is assigned as shown against their names.

In terms of DoPT OM No.11012/6/2016-Estt(A-III) dated 19.01.2017, the promotion granted to the officers is provisional subject to the outcome of appeal that may be filed against the acquittal of the above officers and also subject to the final outcome of the order of the Hon'ble Supreme Court of India in the case of SLP No. 30621/2011 (Jarnail Singh and Others vs. Lachhmi Narain Gupta and Others) and any other cases pending in any Courts/Tribunal.
